Dear Mr. Sayen:

This is in reply to your letter of July 14, 1959, concerning Civil Air Regulations Draft Releases 59-4, 59-5 and 59-6.

With respect to your request to examine the data, studies, and material used by this Agency in developing the proposed rules, we are enclosing a bibliography listing publications which constituted a reference source in the study and preparation of these proposals. The draft releases referred to "available" data, methods, studies, and material as information which is generally available. Since this Agency does not maintain a comprehensive library of such reference materials and since you indicate that your Association wishes to conduct a comprehensive review, we would suggest that you use the enclosed bibliography for reference to the sources of material which you wish to review.

We should be glad to meet with any representatives of your Association to discuss the reference material which has been kept on file. This, however, is not representative of all the material considered in the preparation of the draft releases.

With respect to your inquiry concerning the conduct of hearings for the purpose of presenting evidence in response to the publication of the draft releases, a decision concerning the need for such hearings will be held in abeyance until the total comments have been received.
